

PRIVACY POLICY Updated for GDPR

Lori Kochevar, MS, LPC and those she designates as support staff for website maintenance at www.spirit-evolving.com respect each individual's right to personal privacy. Lori Kochevar, MS, LPC and those she designates as support staff for the website will collect and use information through her web site only in the ways disclosed in this statement. Part I. Information Collection and Security

User Submitted Assessments

Other information may include now or in the future: user-submitted news and events, uploaded photos, profiles, private messages and blog posts or forums. The information is collected by the voluntary submittal of such by registered users.

Third party applications mentioned above may also collect information and you are advised to review their own Privacy Policies for any additional data collection and security.

The personal information we collect has been provided by you, when you:

Register for a Client Service (including consultations, classes, telecalls, seminars, workshops, retreats or forums or blogs)

Sign up to our newsletter

Request information from or send an email to Lori Kochevar, MS, LPC or those she designates as support staff for website maintenance.

Use text or phone contact to register for mail lists or client services
